Sub: Consolidated Scrutinizer's Report for Remote E-voting and Electronic Voting at the Annual General Meeting (AGM) of the Company held on Monday, 22nd September, 2025.

The Board of PRO FX Tech Limited (PROFX) at its meeting held on 11th August 2025 had appointed me as Scrutinizer for the e-voting process for the Annual General Meeting (AGM) of the members of the company held on **September 22nd, 2025.**

Pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of Companies (Management and Administration) Rules, 2014 as amended and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 the Company has confirmed that the notice convening the AGM of the company along with the instructions for the remote e-voting and electronic voting at the AGM were sent through electronic mode to those members whose e-mail addresses were registered with the company/Depository Participant(s) for communication purposes in compliance with MCA Circulars dated 19th September, 2024, 25th September, 2023, 28th December, 2022, 05th May, 2022, 14th December, 2021, 13th January, 2021, 05th May, 2020, 13th April, 2020 and 8th April, 2020 (collectively referred to as 'MCA Circulars') and SEBI circulars dated 03rd October, 2024, 07th October, 2023, 05th January, 2023, 13th May, 2022, 15th January, 2021 and 12th May, 2020 (collectively referred to as 'SEBI Circulars'). Further the company issued notice of AGM on 29th August, 2025, the same was duly uploaded on the website of the company and stock exchanges.

Pursuant to Section 108 of the Act read with the Rules and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 the Company has provided remote e-voting facility and also electronic voting facility at the AGM to its members in respect of business to be transacted at AGM.

The Company has appointed NSDL as the service provider for the facility of remote e-voting as well as the electronic voting facility at the AGM to those members of the company who had not cast their vote through remote e voting.
